13 **ADMINISTRATIVE ORDER 2026-05(A)**

14 The Second Judicial District Court ("SJDC") Chief Judge has authority to make
15 administrative decisions pertaining to the business of the court (WDCR 2(2), NRS
16 3.025(2)(c)). The SJDC Chief Judge finds the prudent management of stored evidence is in
17 the interest of justice and judicial economy. The management of evidence in civil cases is
18 governed by NRS 3.305, 3.307 and ADKT 410 (*Corrected Order Adopting Protocol for*
19 *Storage, Retention and Destruction of Evidence, Mar. 9, 2010*). The release and/or
20 destruction of evidence maintained and stored by the SJDC is necessary to effectuate the
21 orderly administration of justice.

24 The cases identified in Exhibit 1 are ones in which the final judgment has been filed
25 and the case has been closed for at least two (2) years. The Exhibit 1 cases have no
26 pending appeals before the Nevada Supreme Court or Court of Appeals and have no
27 pending federal court cases regarding the civil matter in question.

Accordingly, and good cause appearing therefor,

1 **IT IS HEREBY ORDERED:**

2 1. The exhibits held by the Evidence Clerk for the civil cases identified in Exhibit
3 1 ("Evidence") in the SJDC secured evidence room are identified as eligible for review and
4 release or destruction.

6 2. The Evidence Clerk is directed to provide notice to the parties through the law
7 firm or solo practitioner designated as counsel of record or the party, if self-represented
8 (generally referred to as "counsel") after a diligent search for the current address ("Notice").
9

10 3. The Notice will advise counsel the Evidence held for the civil case is available
11 for review and retrieval or consent to destruct within thirty (30) days of the date of the
12 Notice. The Notice will also advise review and retrieval will occur by appointment only made
13 by contacting Evidence Clerk Kayla Hudson at evidence@washoecourts.us
14

15 4. If, within thirty (30) days of the Notice date, counsel consents to destruction of
16 the Evidence or counsel does not make an appointment to retrieve the Evidence, the
17 Evidence Clerk shall dispose of the Evidence and file a Certificate of Destruction.

18 5. The Evidence held by the SJDC in the cases identified in Exhibit 1 shall be
19 released and/or disposed of in accordance with NRS 3.305, 3.307 and ADKT 410
20 (*Corrected Order Adopting Protocol for Storage, Retention and Destruction of Evidence,*
21 *Mar. 9, 2010*) forthwith.

23 IT IS SO ORDERED.
