WHEREAS, the Judges of the District unanimously voted on December 9, 2008, that the case load of the Chief Judge be reduced; and

WHEREAS, the District Court Administrator has identified cases randomly to be removed from the Chief Judge's department and assigned to the former Chief Judge Connie Steinheimer.

**IT IS HEREBY ORDERED:**

1. The cases randomly identified and set forth in Exhibit A to this order shall be transferred from Department 15 to Department 4, effective January 30, 2012.
