ADMINISTRATIVE ORDER 2014-2

Whereas, the undersigned was re-elected as the Chief Judge of the Second Judicial District Court, effective January 6, 2014, and

Whereas, certain assignments are necessary to effectuate the orderly administration of justice within the District Court,

It is hereby ORDERED as follows:

1. Judge Deborah Schumacher shall continue serving as the Presiding Judge of the Family Division of the Second Judicial District Court. See WDCR 2(4); WDCR 30(1)(a).
2. Judge Linda Gardner shall continue her administrative responsibilities over Domestic Violence. See WDCR 30(1)(e)(1).
3. Judge Egan Walker was previously designated as the Juvenile Delinquency Judge. See WDCR 30(1)(e)(2). Judge Walker shall perform additional administrative responsibilities over Child Dependency in coordination with Judge Deborah Schumacher.
4. Judge Deborah Schumacher shall perform additional administrative responsibilities over the Second Judicial District Court's Specialty Courts, in coordination with the senior judges managing the Specialty Courts. Judge Schumacher shall also continue serving as the Minor Guardianship judge as contemplated in Administrative

1 Order 08-07.

2 5. Judge Frances Doherty shall continue serving as the Adult Guardianship
3 Judge as contemplated in Administrative Order 08-05.

4 6. Judge Bridget Robb Peck shall continue to provide administrative
5 responsibilities over Child Support Enforcement (UIFSA). See WDCR 30(1)(e)(3). Judge
6 Peck shall also continue serving as the presiding judge over the Alternative Dispute
7 Resolution Program. See Administrative Order 09-04.

8 7. Judge Chuck Weller shall continue his administrative responsibilities over
9 Mental Health/Developmental Disability Involuntary Civil Commitment. See WDCR
10 30(e)(5). Judge Weller shall also continue his administrative responsibilities over the Self-
11 Help Center.

12 8. Judge Elliott Sattler shall serve as the Foreclosure Mediation Judge. See
13 Administrative Order 2012-2, at 3:16, para. 1.

14 9. Judges Brent Adams, Patrick Flanagan, and Bridget Robb Peck shall continue
15 serving as the Business Court Judges within the Second Judicial District Court. See
16 Administrative Order 09-03.

17 10. Judge Connie Steinheimer shall continue serving as the Probate Judge for the
18 Second Judicial District Court. See Administrative Order 09-02. Judge Steinheimer shall
19 also continue serving as the presiding judge over the Short Trial Program. See
20 Administrative Order 09-04.

21 11. Judges Connie Steinheimer, Chuck Weller, and Lidia Stiglich shall be ex
22 officio trustees of the Washoe County Law Library Board. See NRS 380.020

23 12. The Chief Judge shall continue supervisory and administrative
24 responsibilities over the Grand Jury.

25 13. The term "administrative responsibility" means, as applicable: 1) presiding
26 over objections to masters' recommendations, and 2) assuming primary responsibility for
27 court policy involving designated case categories and related areas of law.


