## **ADMINISTRATIVE ORDER 2016-06**

- 4. Judge Egan Walker shall have administrative responsibility for Juvenile Delinquency, Juvenile Dependency, and Minor Guardianships. See WDCR 30(1)(e)(2) and WDCR 30(1)(e)(4).
- 5. Judge Chuck Weller shall have administrative responsibility for Orders for Protection Against Domestic Violence and the Self Help Center. See WDCR 30(1)(e)(1).

- 6. Judge Frances Doherty shall serve as the Adult Guardianship Judge as described in Administrative Order 08-05.
- 7. Judge Cynthia Lu shall have administrative responsibility for Mental Health/Developmental Disability Involuntary Civil Commitment. See WDCR 30(e)(5).
- 8. Judge Connie Steinheimer shall serve as the Presiding Judge over the Short Trial Program. See Administrative Order 09-04.
- 9. Judge Connie Steinheimer, Judge Chuck Weller, and Judge Lidia Stiglich shall serve as ex officio trustees of the Washoe County Law Library Board. See NRS 380.020.
- 10. Judge Lynne Simons shall serve as the Presiding Judge for the Alternative Dispute Resolution Program. <u>See</u> Administrative Order 09-04. In case of conflict, Judge Janet Berry shall serve as the Alternate Arbitration Judge.
- 11. Judge Elliott Sattler shall have administrative responsibility for the Pretrial Services Division, in coordination with the Pretrial Services Manager
- 12. Chief Judge Patrick Flanagan, Presiding Judge Bridget Robb, and Judge Scott Freeman shall serve as the Business Court Judges.
- 13. Judge Lidia Stiglich shall serve as a Probate Judge as set forth in AO 2014-05 and to have administrative responsibility for Probate program. Judge Jerry Polaha and Judge David Hardy shall serve as alternative Probate Judges as set forth in AO 2014-05. Judge Lynne Simons shall also serve as an alternative Probate Judge.
- 14. Judges Senior Judge Peter Breen, Senior Judge Archie Blake, Judge Deborah Schumacher shall remain as Specialty Court Judges as set forth in Administrative Order 2016-03. Judge David Hardy shall serve as a Specialty Court Judge for Veterans Court.
- 15. All Foreclosure Mediation cases shall be randomly assigned among the General Jurisdiction Judges. This Administrative Order specifically modifies AO 2012-02.
