**ADMINISTRATIVE ORDER 2016-15**

WHEREAS, in June 2015, the Committee to Study Evidence-Based Pretrial Release (Committee) was created by the Judicial Council of the State of Nevada; and

WHEREAS, the purposes of the Committee are to study the current pretrial release system and to examine alternatives and improvements to that system through evidence-based practices and current risk assessment tools; and

WHEREAS, a risk assessment tool has been implemented as a pilot project in Clark, Nye and Washoe Counties; and

WHEREAS, in Washoe County, judicially imposed bail has been implemented as a pilot project; and

WHEREAS, during the pilot project, the Washoe County Uniform Bail Schedule, effective February 14, 2012, is not necessary; and

WHEREAS, using the Washoe County Uniform Bail Schedule during the pilot project timeframe will impede the implementation of the judicially imposed bail process.


