**ADMINISTRATIVE ORDER 2017-11**

WHEREAS, certain assignments are necessary to effectuate the orderly administration of justice within the Second Judicial District Court.

3. Judge David Humke shall have administrative responsibility for Child Support Enforcement/UIFSA. *See* WDCR 30(1)(e)(3).
4. Judge Egan Walker shall have administrative responsibility for Juvenile Delinquency, Juvenile Dependency, and Minor Guardianships. *See* WDCR 30(1)(e)(2) and WDCR 30(1)(e)(4).
5. Judge Chuck Weller shall have administrative responsibility for Orders for Protection Against Domestic Violence. *See* WDCR 30(1)(e)(1).

1           6.       Judge Bridget Robb shall have administrative responsibility for the Self  
2 Help Center. *See* WDCR 30(1)(e) and serve on any other board or committee which  
3 requires a family court representative. *See* WDCR 30(1)(g)(2).

4           7.       Judge Frances Doherty shall serve as the Adult Guardianship Judge as  
5 described in Administrative Order 08-05.

6           8.       Judge Cynthia Lu shall have administrative responsibility for Mental  
7 Health/Developmental Disability Involuntary Civil Commitment. *See* WDCR  
8 30(e)(5).

9           9.       Judge Connie Steinheimer shall serve as the Presiding Judge over the  
10 Short Trial Program. *See* Administrative Order 09-04.

11          10.       Judge Connie Steinheimer, Judge Chuck Weller, and Judge Scott  
12 Freeman shall serve as ex officio trustees of the Washoe County Law Library Board.  
13 *See* NRS 380.020.

14          11.       Judge Lynne Simons shall serve as the Presiding Judge for the  
15 Alternative Dispute Resolution Program. See Administrative Order 09-04. In case  
16 of conflict, Judge David Hardy shall serve as the Alternate Judge for the Alternative  
17 Dispute Resolution Program.

18          12.       Judge Elliott Sattler shall have administrative responsibility for the  
19 Pretrial Services Division, in coordination with the Pretrial Services Manager.

20          13.       Judge David Hardy, Judge Lynne Simons and Judge Kathleen  
21 Drakulich shall serve as the Business Court Judges.

22          14.       Judge David Hardy shall serve as a Probate Judge and will have  
23 administrative responsibility for the Probate program. Judge Jerry Polaha and Judge  
24 Lynne Simons shall serve as alternative Probate Judges.

25          15.       Senior Judge Peter Breen, Senior Judge Archie Blake, and Senior Judge  
26 Deborah Schumacher shall remain as Specialty Court Judges, as set forth in  
27 Administrative Order 2016-03. Judge Steinheimer will be liaison between the  
28 Specialty Courts and the Second Judicial District Court.
