ADMINISTRATIVE ORDER 2017-14

WHEREAS, Continuing Part-Time Masters serve on a part-time basis under a continuing appointment;

WHEREAS a Continuing Part-Time Master may include a retired judge or master subject to recall who are permitted to practice law in this State. See Application III (A); Opinion: JE99-004 (citing Nevada Code of Judicial Conduct Terminology);

WHEREAS, Continuing Part-Time Masters shall not practice law in the court for which the master serves or any court subject to the appellate jurisdiction of the court in which the master serves, and shall not act as a lawyer in a proceeding in which the master has served as a master or in any other proceeding related thereto. See Opinion: JE99-004 (citing Section C Application of the Nevada Code of Judicial Conduct);

WHEREAS, Continuing Part-Time Masters are subject to the same educational requirements as full-time masters set forth in ADKT 251, NRS 62B.020, and ADKT 168 (training for masters handling domestic violence matters) as applicable; and


1 WHEREAS, Continuing Part-Time Masters may perform specified duties within the Family  
2 Division and Juvenile Court, upon recommendation from the Presiding Judge of the Family  
3 Division.

4 **IT IS HEREBY ORDERED:**

- 5 1. Sue Edmondson, Esq., and Cassandra Campbell, Esq., are appointed Continuing  
6 Part-Time Hearing Masters of the Family Division and Juvenile Court in the Second  
7 Judicial District Court.
- 8 2. The above-named Continuing Part-Time Hearing Masters shall serve at the direction  
9 of the Presiding Judge of the Family Division.
- 10 3. This Administrative Order specifically modifies Administrative Order 2014-11 and  
11 2015-06.
- 12 4. This appointment shall remain in effect until modified by a subsequent  
13 Administrative Order.
