APPOINTING THE PUBLIC GUARDIAN.

ADMINISTRATIVE ORDER 2019-03

WHEREAS, the Second Judicial District Court Chief Judge has authority to make administrative decisions pertaining to the business of the Court pursuant to WDCR 2(2), NRS 3.025(2)(c));

WHEREAS, the Washoe County Public Guardian serves at the pleasure of the Washoe County Board of County Commissioners for a term of four years pursuant to NRS 253.150 (2); and

WHEREAS, Susan DeBoer served as Public Guardian from 2005, until her retirement from such position, effective October 5, 2018; and

WHEREAS, Kate Thomas served as acting Public Guardian; and

WHEREAS, the Washoe County Board of County Commissioners has appointed TRACEY BOWLES, as the Public Guardian; and

WHEREAS, amended letters of guardianship must reissue reflecting TRACEY BOWLES as the Public Guardian; and

1 WHEREAS, it is critical that the Washoe County Public Guardian remain able to
2 execute its duties uninterrupted to serve the needs of protected persons and proposed
3 protected persons over whom the Washoe County Public Guardian has been appointed; and

4 WHEREAS, it is necessary to effectuate, in an orderly and efficient manner, the
5 reissuance of letters of guardianship naming TRACEY BOWLES the Public Guardian.

6 IT IS HEREBY ORDERED:

7 1. TRACY BOWLES is acknowledged as Public Guardian in the cases attached
8 hereto.

9 2. The Second Judicial District Court shall allow successor letters of
10 guardianship to issue to TRACEY BOWLES, upon her taking the oath required by NRS
11 159.073 and NRS 253.160, without need for a separate petition for appointment of
12 successor guardian.

13 3. Pursuant to NRS 159.074(1), the Public Guardian must serve the protected
14 person with a copy of this Order within five days of its issuance.

15 4. This Administrative Order becomes effective immediately and revokes
16 Administrative Order 2018-18 regarding acting Public Guardian, Kate Thomas.

17 IT IS SO ORDERED.
