ADMINISTRATIVE ORDER 2019-06

WHEREAS, the Second Judicial District Court Chief Judge has authority to make administrative decisions pertaining to the business of the Court (WDCR 2(2), NRS 3.025(2)(c));

WHEREAS, the Chief Judge shall assign cases to each judge in the judicial district (NRS 3.025(2)(a));

WHEREAS, certain assignments are necessary to effectuate the orderly administration of justice within the Second Judicial District Court;

WHEREAS, the Second Judicial District Court has a robust Specialty Courts Program;

WHEREAS, the mission of the Second Judicial District Court's Specialty Courts is to improve the quality of life, reduce recidivism, and increase community safety and awareness by engaging the drug and alcohol abusing offender or the offender with a mental health illness in an intensive, court supervised, treatment program;

WHEREAS, the National Association of Drug Court Professionals (NADCP) has identified best practice standards for Specialty Courts programs;

WHEREAS, in August of 2018, the General Jurisdiction Division of the Second Judicial District Court voted to implement the NADCP best practice standards for its Specialty Courts;

1 WHEREAS, one of the NADCP best practice standards is to have one judge preside over a
2 Specialty Courts program, thus creating a stronger relationship between the participants and the
3 judge and resulting in better outcomes for the participants;

4 WHEREAS, since 2015, the Honorable Deborah Schumacher has presided over Specialty
5 Courts in the Second Judicial District Court, positively impacting participants' lives, and has been
6 the single judge presiding over Specialty Courts since January 1, 2019;

7 WHEREAS, the Second Judicial District Court has determined that judicial resources can be
8 better utilized and Specialty Courts participants thereby better served by an elected member of the
9 Second Judicial District Court Bench preside over Specialty Courts; and

10 WHEREAS, the Second Judicial District Court is indebted to the Honorable Deborah
11 Schumacher for her service to the participants in the Specialty Courts, and commends her
12 dedication, commitment, and expertise that has greatly enhanced the District's Specialty Courts
13 program.

15 **IT IS HEREBY ORDERED:**

- 16 1. Effective June 3, 2019, the Honorable Jerome Polaha will preside over the Second Judicial
17 District Court's Specialty Courts Program. Youth Offender Diversion Court shall continue
18 to be presided over by the Honorable Scott Freeman. Family Treatment Court shall continue
19 to be presided over by the Honorable Cynthia Lu.
- 20 2. Effective June 3, 2019, no criminal or civil case types shall be assigned to Department 3,
21 with the exception of cases assigned to the Specialty Courts Program.
- 22 3. Court Administration shall randomly reassign to Departments 1, 4, 6, 7, 8, 9, 10 and 15 all
23 existing criminal and civil matters currently assigned to Department 3. A list of case
24 reassignments shall be attached to this order.

- 1 4. For civil case assignments, parties shall be given until June 14, 2019, within which to file a
2 peremptory challenge with respect to the newly assigned judicial officer. This order shall
3 serve as notice pursuant to SCR 48.1(4) that a case has been reassigned to a new judicial
4 officer. For the purposes of SCR 48.1(4), notice of reassignment will be deemed to have
5 occurred on June 11, 2019.
- 6 5. This order supersedes Administrative Order 2018-19.
