

13 Henceforth, the Director of the Washoe County Department of Juvenile Services
14 shall, in the event of an emergency requiring the evacuation of detainees housed at a
15 juvenile detention facility located within Washoe County, namely the McGee Center,
16 located at 2097 Longley Lane, Reno, Nevada 89502, or the Jan Evans Center, located at 650
17 Ferrari McLeod, Reno, Nevada, 89512, have the authority and discretion to assess each
18 individual placement and either temporarily release the detainee to the custody of his or
19 her parent(s) or guardian(s) or to place the detainee in another detention facility within the
20 region until such time as it is safe to return to the facility, without further order of this
21 Court.
