20 ADMINISTRATIVE ORDER 08-03

21 On February 19, 2008, Sierra Pacific Power Company petitioned the Court for an
22 Order to permit them to enter lands to conduct surveys and other tests. This request is
23 based upon their future expansion of an existing easement on a large tract of land
24 owned by several separate entities. Sierra Pacific Power Company filed eleven (11)
25 separate cases; Case Nos. CV08-00380 through CV08-00390. These cases were
26 randomly assigned to Departments Four, Six, Eight, Nine and Ten.

1 After review of the files, the Court finds it is appropriate to transfer all of these
2 cases into one judicial department, Department Eight, where the original case was filed.


3 Transferring these cases into one department would guarantee a more efficient
4 use of party and judicial resources. Transferring would not create inconvenience, delay
5 or expense, but rather will avoid unnecessary costs and reduce duplicative efforts. The
6 Court finds no risk of prejudice exists that outweighs the benefits of having one judicial
7 officer handle these actions.
