13 ADMINISTRATIVE ORDER 11-03

14 WHEREAS, the Municipal, Justice and District Courts of Washoe County have  
15 convened through their Chief and Administrative Judges as the Judicial Effectiveness  
16 Committee to promote the effective and efficient administration of the criminal justice  
17 system in Washoe County, and

18 WHEREAS, the courts have considered and agreed that it would promote the  
19 uniform administration of justice if all of the courts adopted and agreed to a uniform bail  
20 schedule so that any defendant arrested in Washoe County, no matter the applicable  
21 court, would have the same bail imposed, and

22 WHEREAS, the Judicial Effectiveness Committee has met and considered at  
23 length the adoption of uniform misdemeanor and felony bail schedules, and

24 WHEREAS, the attached misdemeanor and felony bail schedules with  
25 explanatory tables have been approved and adopted by the Judicial Effectiveness  
26 Committee and the individual courts,


27 IT IS HEREBY ORDERED THAT, effective February 14, 2012, at 12:00 a.m., the  
28 attached bail schedules will apply thereafter to any arrest made in Washoe County by

1 any law enforcement agency seeking to book accused defendants into the Washoe  
2 County Jail, and

3 IT IS FURTHER ORDERED THAT, as of the joint adoption of this order, that  
4 copies of this order, the misdemeanor and felony bail schedules, and supporting tables  
5 be distributed to all applicable law enforcement agencies so that necessary steps can  
6 be taken to amend their internal procedures and computer systems to reflect the  
7 changes in the Uniform Bail Schedule for Washoe County, and


8 IT IS FURTHER ORDERED THAT, the Uniform Bail Schedule for Washoe




The Sparks Township Justice Court






