1 CONCLUSIONS OF LAW

2 The Family Division of the Second Judicial District Court of the State of Nevada, in and for the
3 County of Washoe, has jurisdiction over the parties and issues to enter this Decree of Annulment.

4 DECREE OF ANNULMENT

5 Petitioners are hereby granted a Decree of Annulment, dissolving and declaring null and void
6 the marriage that took place and each is returned to the status of unmarried person.

7 Each party shall have set aside to them, as individuals, the debts they incurred and shall hold the
8 other party harmless therefrom.

10 brought to the union as individuals.
