Electronically Filing the Documents

A guardian will need to upload the original documents to eFlex. EFlex is available online at <https://wcefex.washoecourts.com/>, and at the Second Judicial District Court.

A guardian will need to sign into their eFlex account using the username and password they created and electronically file the:

- Consent to Waive Publication of the Notice of Sale

Make sure to keep the original documents for your personal records. File-stamped copies of your documents are available through your eFlex account.

Scanners are available at the Second Judicial District Court.
