A copy machine is available at the Law Library located on the first floor of the courthouse at 75 Court Street, Reno, NV (to the left of the Filing Office). There is a per page charge to use the copy machine.

The Filing Office will file and keep the original Minor's Declaration of Consent and return file-stamped copies to you. Please make sure to provide one file stamped copy to the consenting parent and keep one copy for your personal records.
