Step 1 – Complete the Following Documents:

1. *Declaration of Petitioner*
 - a. Attach a copy of your work identification or credentials.
2. *Order Granting Request for Confidentiality*
 - a. You will leave the Judge’s signature line blank. This will be signed and dated by the Court at the time the Order is granted.

Step 2 – File the Documents

Step 3 – Provide a copy of your order to:

4 IT IS HEREBY FURTHER ORDERED that this Order shall remain in effect until further
5 order of this Court, the real property is sold or conveyed or if Petitioner signs a consent with the
6 Assessor's Office to disclose confidential information pursuant to NRS 250 by providing a
7 written sworn statement made under oath to the Washoe County Assessor, indicating the manner
8 of said disclosure.

9 IT IS HEREBY FURTHER ORDERED that upon evidence sufficient to the Washoe
10 County Assessor that the real and/or personal property subject to this Order has been conveyed
11 from a person herein named in this Order, the Washoe County Assessor may without further
12 order of this Court terminate the non-disclosure of confidential information as delineated herein.

13 IT IS HEREBY FURTHER ORDERED that this Order shall be sealed and access will
14 not be allowed to anyone without a court order.
