POSITION DESCRIPTION

As an independent contractor with the Specialty Courts Department, the Licensed Clinical Social Worker/Marriage Family Therapist will provide comprehensive evaluations to participants involved in the Second Judicial District Court's Adult Drug Specialty Court. Work responsibilities include providing evaluation services and assistance to Court staff with participant referral and linkage to community resources. Incumbents must possess a degree of knowledge and proficiency sufficient to perform work independently; though, training will be provided as needed.

Incumbents must also be Licensed Alcohol and Drug Counselors, proficient in DSM 5 assessment, justification and diagnosis of substance misuse and mental health disorders, Cross Cutting Symptom Measure screening tool, and ASAM Levels of Care.

Position works as an independent contractor. Monthly pay based on completed evaluations at rate of \$160/clinical evaluation. Projected to serve 50 participants in initial 9-month period, beginning October 1, 2019.
