The Board Chair may order the removal of any person whose statement or other conduct disrupts the orderly, efficient, or safe conduct of the meeting. Warnings against disruptive conduct may or may not be given before removal. The viewpoint of a speaker will not be restricted, but reasonable restrictions may be imposed upon the time, place and manner of speech. Irrelevant and unduly repetitious statements and personal attacks which antagonize or incite others are examples of speech that may be reasonably limited.

NOTE: Items on the agenda may be taken out of order; combined with other items; removed from the agenda; moved to the agenda of another later meeting; or may be voted on in a block. Items with a specific time designation will not be heard prior to the stated time, but may be heard later.

Accessibility. In compliance with the Americans with Disabilities Act, those requiring accommodation for this meeting should notify the Washoe County Law Library at (775) 328-3250, 24 hours prior to the meeting.

<u>**Time Limits.</u>** Public comments are welcomed during the Public Comment periods for all matters, whether listed on the agenda or not, and are limited to three minutes per person. Additionally, public comment of three minutes per person will be heard during individual action items on the agenda. Persons may not allocate unused time to other speakers.</u>

<u>Public Comment.</u> Members of the public may submit public comment in person at the meeting, or by logging into the ZOOM webinar listed above. Members of the public may also submit public comments ahead of time via email to <u>sarah.bates@washoecourts.us</u>.

Responses to Public Comments. The Board of Trustees can deliberate or take action only if a matter has been listed on an agenda properly posted prior to the meeting. During the public comment period, speakers may address matters listed or not listed on the published agenda. The Open Meeting Law does not expressly prohibit responses to public comments by the Board of Trustees. However, responses from Board members to unlisted public

comment topics could become deliberation on a matter without notice to the public. On the advice of legal counsel and to ensure the public has notice of all matters the Board of Trustees will consider, Board of Trustees may choose not to respond to public comments, except to correct factual inaccuracies, ask for staff action or to ask that a matter be listed on a future agenda. The Board of Trustees may do this either during the public comment item or during the following item: "Board Comment – Limited to Announcements or Issues for Future Agendas."

Meeting Minutes

November 16, 2022

1. Roll Call

Board Members present:

Chief Judge Lynne Simons, Honorable Connie Steinheimer, Cortney Young, Kathi Lutsch and Mike Kattelman.

Honorable Tamatha Schreinert joined at 12:08p.m.

Also present were:

Sarah Bates, Washoe County Law Librarian, Assistant Court Administrator, Alicia Lerud, District Court Administrator and Clerk of the Court, and Trenton Ross, Deputy District Attorney

2. Public Comments:

None.

3. Approval of Minutes from Board Meeting of September 7, 2022. For Possible Action.

Deputy District Attorney, Trenton Ross noted he was listed twice in the minutes and asked that be corrected.

Motion to approve the minutes as amended was made by Chief Judge Simons and seconded by Judge Schreinert.

No discussion was had.

Motion passed unanimously.

4. Board Membership- Nomination and selection of one attorney member and one non-attorney member. Each applicant will have an opportunity to speak to the Board. For possible action.

The Board took up consideration of the attorney member application first. Trustee Kattelman spoke about his application and desire to continue serving. Trustee Young made a motion to send Trustee Kattelman's application to the Board of County Commissioners for approval as the attorney candidate for the Board. That motion was seconded by Trustee Lutsch.

No discussion was had. The motion passed unanimously. Trustee Kattelman abstained from the vote.

Next, the Board took up consideration of the non-attorney applicants. Judge Steinheimer thanked Trustee Lutsch for her service and contributions to the Board.

The Board heard from all applicants individually. Applicant Dale Way withdrew his application from consideration.

After hearing from the applicants, the Board considered each and Judge Schreinert commented that she was pleased to have so much interest in the position. Judge Schreinert then made a motion to send Aurora Partridge's application to the Board of County Commissioners for approval and appointment to the Law Library Board of Trustees. The motion was seconded by Trustee Lutsch.

Chief Judge Simons made comments related to the distinction in library systems and inquired as to new board member training.

Trustee Kattelman remarked that he was also pleased by the quality of the candidates and noted that there are other ways for people to get involved with the Board should they not be chosen as a Board member.

Judge Steinheimer called for the question and asked that the motion be repeated. Trustee Young repeated the motion to the Board and Judge Steinheimer called for the vote. No further discussion was had.

Motion passed unanimously.

5. Update regarding Lawyer in the Library Volunteer Recognition Event.

The event will be held on February 1, 2023, in person. Library staff is moving forward with planning and WCBA has approved the budget for the event. Cherry Bomb Catering will be providing the food again this year. The Board discussed logistics of the event.

No action was taken.

6. Status update from Mike Kattelman and discussion about the informational video project about the court system and court procedure for the public. For possible action.

Judge Steinheimer started by thanking Trustee Kattelman for his work on these videos and expressed gratitude for his efforts. Judge Schreinert wished to also thank Trustee Kattelman for his work on the videos and commented that she believed the length of the videos may be a concern. She noted that she enjoyed the conversational style best.

Chief Judge Simons echoed the comments of Judge Steinheimer and Judge Schrienert. She also had concerns over the length and suggested shorter chapters as a potential solution. Chief Judge Simons also noted a concern about diversity in the videos to ensure that those speaking look like our community. Trustee Kattelman agreed and noted that he has a potential solution for that.

Trustee Young similarly thanked Trustee Kattelman for his work and agreed with Chief Judge Simons that chapters could be a solution to the length concern. Trustee Young also noted concerns that differently abled people in the community be considered when making the content and proposed closed captioning to accompany the spoken portions of the videos. Additionally, Trustee Young commented that legal jargon or legalese may not be appropriate for self-represented persons.

Trustee Lutsch echoed the comments of Trustee Young.

Judge Steinheimer commented that our self-help packets are written for a certain reading level and that should be considered as we move forward with these materials as well.

Trustee Kattelman thanked the Board for their input.

No action taken.

7. Discussion and possible approval of next year's meeting dates. For possible action.

The Board considered the proposed dates for the year 2023. Ms. Bates noted that the February time should be a.m. not p.m. and Judge Steinheimer asked if that would be in person.

With those changes, the Board approved the dates unanimously.

8. Board Comment – Limited to Announcements or Issues for Future Agendas.

Judge Schreinert thanked the library staff for all of their hard work and noted her appreciation.

Judge Steinheimer thanked Trustee Lutsch again for her service and dedication to the Board over the years and relayed that she was a valued member and will be missed.
