22 **ORDER GRANTING EX PARTE MOTION TO SERVE BY PUBLICATION**

23 This matter came before the Court on Plaintiff B&J Industries, LLC's Ex Parte
24 Motion to Serve by Publication.

The Court finds that American Standard Equipment, LLC, the defendant identified
in this action, cannot be presently found within the State of Nevada, and that summons herein
cannot be served upon said defendant; it appears from said motion and accompanying declarations
and from Plaintiff's Complaint filed herein that a cause of action exists in favor of Plaintiff and
against Defendant, and that said Defendant is a necessary and proper party; and it further appears

1 that the Reno Gazette Journal is a newspaper circulating in Reno, Nevada, and is the newspaper
2 most likely to give notice to said Defendant of the pendency of this action;

3 **NOW, THEREFORE, IT IS HEREBY ORDERED**, pursuant to Nev. R. Civ. P.
4 4.4(c), that the summons in this suit shall be served on said Defendant by publication thereof in
5 the Reno Gazette Journal and that said publication be made for a period of four consecutive weeks
6 and at least once a week during said time.

7 **IT IS FURTHER ORDERED** that Plaintiff shall serve the Nevada Secretary of
8 State in the entity's stead by delivering a copy of the summons and complaint to the Nevada
9 Secretary of State or his or her deputy; and posting a copy of the summons and complaint in the
10 office of the clerk of the court in which such action is pending. *See* Nev. R. Civ.P 4.2(c)(3).

11 **IT IS FURTHER ORDERED** that Plaintiff shall mail a copy of the summons and
12 complaint to the Defendant's last known address. 07/09/25
